Dear Sir,

In pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosures Requirements) 2015, we wish to inform you that the company has received Order from the Pondicherry Industrial Promotion Development and Investment Corporation Limited (PIPDIC), Puducherry vide order No. F 31-08/10-11/Dev/795-IV/1140 dated 27.06.2018 received on dated 02.07.2018 for cancellation of lease deed alleging the non compliance of lease terms and to take over the possession of the unit on 06.07.2018. In terms of said order, PIPDIC has taken over the possession of the unit today even after submitting the reply of the company vide letter dated 03.07.2018 justifying that there is no case of non compliance of lease terms.

Aggrieved by the said action, company has filed a Writ petition in Hon'ble High Court of Madras, Chennai against the aforesaid order of PIPDIC, Puducherry for stay and necessary relief from the Hon'ble Court against the said order of PIPDIC.
