Dear Sir,

In pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosures Requirements) 2015, we wish to inform you that company had received the Notice under section 13(2) of the Securitisation and Reconstruction of the Financial Assets and Enforcement of Security Interest Act 2002 (SARFAESI Act) read with the Security Interest (Enforcement) Rules 2002 dated August 23 2018 claiming a sum of Rs. 1418.26 Crores from Edelweiss Assets Reconstruction Company Limited. Company had submitted its reply in its defense and offering the settlement on 10.10.2018 which was not accepted by EARC and now in exercise of its powers under section 13 (4) of SARFAESI Act, 2002 and Rule 8(6) Of Security Interest (Enforcement) Rule, 2002, the EARC has taken over the symbolic possession of following units of the company vide possession notice received on 13.2.2019. The EARC is holding about 94% (approximately) of the total secured debt of the company. The details of same with financial impact on the company are as under:


