

  - 1. The equity shares of the company are listed at National Stock Exchange India Limited (NSE) under Scrip Code ALPSINDUS-EQ & Bombay Stock Exchange Limited (BSE) under Scrip Code 530715/ALPSIND. In terms of the resolution passed by the Board of Directors of the company at their meeting held on May 30, 2016, and in pursuant to Regulations 6 & 7 of the SEBI (Delisting of Equity Shares) Regulations, 2009, as amended from time to time, company has submitted the application for Voluntary Delisting of its 39114100 Equity Shares from Bombay Stock Exchange Limited which is still pending with Stock Exchange. The company has filled the Writ Petition before Allahabad High Court for necessary directions in this regard which is pending adjudication. The company is not a defaulter towards BSE Limited. The BSE vide their Letter dated 04.12.2019 has intimated that in terms of SEBI Circular Ref. No. LIST/COMP/OPS/16/2019-2020 Dated June 11, 2019 w.e.f. December 12, 2019 the promoters and promoters group demat accounts have been frozen due to non-payment of ALF.

However in the interest of investors, the company has paid all its dues of Annual Listing Fees to BSE on 27.02.2020 under protest. Presently all the accounts have been defrozen and normalize.
